- (a) Agree(s) that **he or she is/are bound by and will comply with** the Rules and Policies of **SRA** (including but not limited to the SRA Constitution and the SRA Rule Book) as in force from time to time;
- (b) acknowledges that his/her/their failure to comply with such Rules and Policies may result in him/her being disqualified, suspended from events (including future events) and/or subject to other sanctions.

2. Acknowledgment of and assumption of risk

The Member(s), by signing this form, acknowledge(s) and agree(s) that –

- (a) Ski Racing is a dangerous sport in which there is an inherent and significant risks that physical injury, including serious and permanent disability and incapacity and even death (**Injury**), may occur;
- (b) the **Member(s)** understand(s) that training for and/or participating in and/or competing in Ski Racing carries the significant risks as identified in 2(a) above;
- (c) The **Member(s) accept(s) all risks** arising from and associated with Ski Racing, including in relation to **SRA** sanctioned training and/or participation in and/or competing in Ski Racing events organised by or sanctioned by **SRA** and undertakes all such **SRA** sanctioned training and/or participation in and or/competing in Ski Racing events organised by or sanctioned by **SRA** entirely at his/her own risk and with full appreciation of the nature and extent of the risks involved;
- (d) The **Member(s)** waives all of his or her legal rights against and fully **releases and holds harmless SRA**, its servants, its employees, agents and voluntary workers (past or present), from and in relation to all actions, proceedings, suits, claims and other liabilities whether founded in negligence, breach of duty (statutory or otherwise) or howsoever arising for all and any **Injury** sustained by the **Member(s)** in the course of an **SRA** sanctioned training and/or participation in and/or competing in Ski Racing events to the full extent permitted by law;
- (e) The **Member(s)** acknowledge that where he or she is a consumer of recreational services, as defined by any relevant law, certain terms and rights usually implied into a contract for the supply of goods and services may be excluded. The **Member(s)** acknowledge(s) that these implied terms and rights and any liability of **SRA** (or any of them) flowing from them, are expressly excluded to the extent possible by law, by this membership declaration. To the extent of any liability arising, the liability of **SRA** will, at the discretion of **SRA**, be limited to the resupply of the services or the payment of the cost of having the services supplied again.
